The Administrative Volunteer of the Year award was presented to Dr. Bob Tygh, a retired veterinarian who has offered his exceptional skills as a handyman to our clinic since 2008. A Board Member and chair of our Facility Committee, Bob not only oversees major projects like resealing our parking lot, but he personally takes care of all the little odd jobs within our building from changing light bulbs to building a shelf to display our golf trophy. The Clinical Volunteer of the Year award was presented to Scott Donaghy. Scott began volunteering as an evening pharmacist in 2001. Here at The CARE Clinic, we have outstanding Board and Advisory Board members who raise funds and solicit donations to help meet the requirements of the Clinic. Yet they give. Some patients are not able to give and some are. They give what they can. looked like they had been picked up off the street. The donation in the can totaled \$5.80. This peanut can of loose change demonstrated the time and effort a patient put into making sure he could show his gratitude for the services he receives here by offering a donation at the end of his visit.

This is one example of patients' giving throughout the year. Since we opened in 1993, CARE Clinic patients have donated over \$191,000 to our mission. "They" are not only patients of the clinic but financial supporters as well.

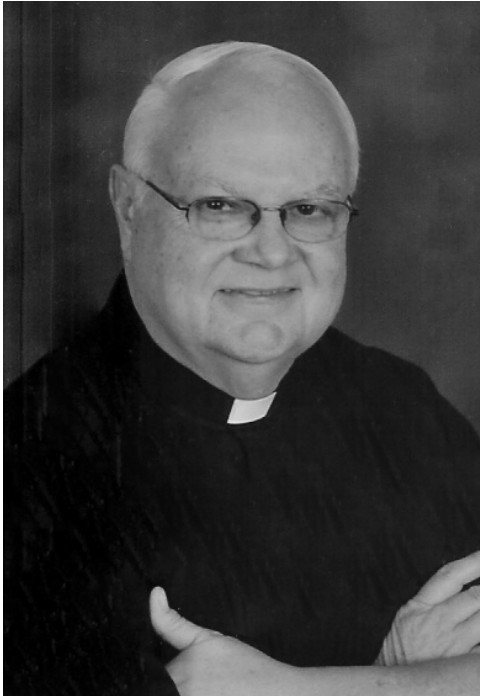

Father John J. "Jack" Kelly has been a strong supporter of The CARE Clinic's mission for many years, generously sharing his time, talents, and treasures with us. Recently Father Kelly again blessed us when he chose to sponsor our Clinical Director's office through our Named Gifts Program.

Originally from New York, Father Kelly was ordained as a Catholic priest in 1968, and received his Masters from Yale Divinity School in 1977. Father Kelly served 25 years in the Army as a Catholic Chaplain. He served in various locations around the world including three assignments to Fort Bragg where he retired as a Lieutenant Colonel in 1995.

Father Kelly started volunteering with The CARE Clinic in 1999 while serving as Senior Pastor at St. Patrick Catholic Church. He was a founding member of our Spiritual

Advisory Committee, which is now our Congregations for CARE Committee. This committee works to strengthen the bond between local religious congregations and our clinic. As a result, we are blessed to have some congregations show their support by providing meals for our volunteers on clinic nights or including a donation in their budget. A few churches even periodically staff an evening clinic.

Father Kelly has been assigned to several different Catholic churches in our area including Lumberton and Stedman. Though he is supposed to be retired now, Father Kelly remains very active and involved throughout the Catholic Community in Cumberland County, including Fort Bragg.

We are honored to have this lasting tribute to Father Kelly at The CARE Clinic.

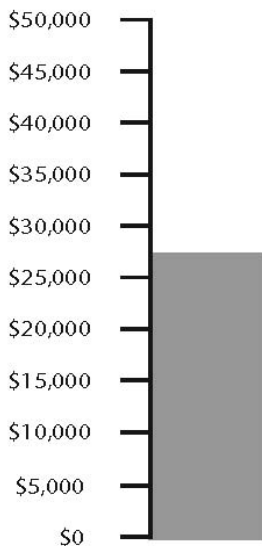
