Accreditation

The CARE Clinic has been awarded Level One Accreditation by the North Carolina Association of Free Clinics. Effective May 4, 2011, this accreditation will remain in effect until July 1, 2014.

The NCAFC Accreditation Program is a voluntary process and a valuable opportunity for member free clinics to improve and enhance clinic programs and services by ensuring they meet compliance standards shared by similar organizations such as a private physician practice. The accreditation process involves three steps: self-evaluation, validator review, and decision by the NCAFC Accreditation Committee.

The award was achieved through the hard work and perseverance of Jim Kerchmar, Board Member, and Jennifer Agee, a Health Administration student from Methodist University. They spent the better part of a year assisting Cathy Ory, Executive Director, in assembling the documents required to show The CARE Clinic's compliance with the accreditation standards.

Psoriasis Cleared

When Diane first came to The CARE Clinic last August, she had been suffering from severe psoriatic arthritis for 7 years. Only 40 years old, she was unable to work due to the constant pain in her ankles, knees and hands. The volunteer physician in our evening clinic prescribed some medication and she was given a follow up appointment for the following month. The return exam showed little improvement so she was referred to our monthly Dermatology clinic.

Dr. Shereff, our wonderful volunteer dermatologist, reviewed Diane's medical history and the medications she had unsuccessfully tried. He arranged for

Diane to be enrolled in our Medication Access and Referral Program to receive a new, injectable, medication at no charge from the pharmaceutical company. Diane was an ideal patient, following doctor's orders and complying with all requests for the paperwork required to file the application for the medication. The application was approved and she started the new medication in March. Within a month, Diane's condition had improved dramatically. The medication is not only clearing her skin, it is giving her a new outlook on life.

Thank you to all our volunteers and donors who enable The CARE Clinic to make such a difference in the lives of our patients.

Project Homeless Connect

Operation Inasmuch sponsored Project Homeless Connect again on Thursday, May 20th at First Baptist Church on Moore Street. The annual event gives the local homeless an opportunity to visit with over forty agencies and learn about services available to them in our community. Fort Bragg soldiers in-processed 339 men, women and children who were treated to breakfast and lunch, and had the opportunity to get flu shots or tetanus shots, make an appointment for job counseling with the Employment Security Commission, and were even able to get a haircut if they wanted one. Many also applied for housing, Social Security, or Medicaid. Attendees who completed a sheet verifying they had visited agency display booths received a gift of a new backpack that was loaded with sample size personal hygiene items.

The CARE Clinic's display was manned by Jean Harrison and Cecilia Marks, members of our Community Relations Committee, who passed out information and answered questions about our services. Dr. Henry Izurieta, Board member and volunteer, provided brief medical exams for patients, assisted by volunteers Harold Estes and Angie Anthony. Better Health of Cumberland County made arrangements with one of their partner pharmacies to fill prescriptions for the patients seen. All agencies involved felt our collaborative effort made a great difference in the lives of the patients seen.

Health Reform Analysis

As with many of you, we continue to follow reports about the expected impact of the Patient Protection and Affordable Care Act (ACA). In a report released in March, the Robert Wood Johnson Foundation analyzed the likely composition of who will remain uninsured. Their findings state:

- The ACA would reduce the number of nonelderly people without health insurance by 28 million, from 18.9 to 8.7%.
- The 19 million nonelderly adults who would still be uninsured under ACA can be divided into five groups:
 - o Thirty-seven percent, mostly young singles without dependents would be eligible for Medicaid, but not enrolled.
 - o Twenty-five percent would be undocumented immigrants.
 - o Sixteen percent would be exempt from the individual mandate because they would not have an affordable insurance option.
 - o Eight percent would be eligible for affordable subsidized coverage. These would be mostly younger singles without dependents.
 - o The remaining uninsured adults would likely be subject to the mandate. These are mostly higher income families with dependents.
