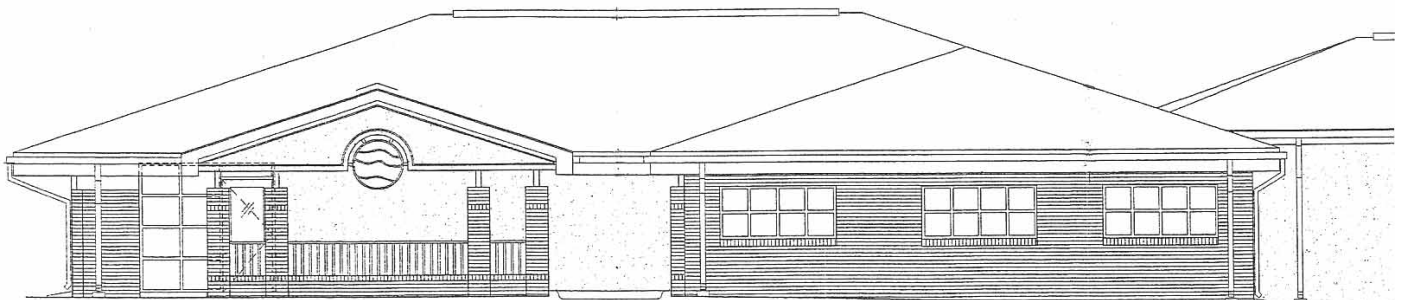

RAISING THE ROOF

The CARE Clinic has suffered from a leaky roof since opening in 1993, a problem common to many buildings with flat roofs. Despite numerous attempts to locate and fix the leaks, the roof continues to leak. Having to continually replace stained ceiling tiles is an annoyance, but moisture infiltration is a concern. Once purchase of our building was complete, our Board of Directors authorized our Facilities Committee to investigate options for renovating the clinic to address the leaky roof problem as well as other aesthetic and structural concerns.

Thomas Goetz, Architect, graciously volunteered his skills and recently presented a wonderful set of plans to the Board for review. The drawing shown here depicts the installation of a sloped roof over the clinic to help eliminate the leaks. A stucco and brick veneer exterior is proposed to replace the peeling paint and help make the building maintenance free. The window air conditioning units in the dental suite are also to be removed to improve the security of our building. Not shown are plans to install a pipe heating system on our above ground water pipes to prevent the pipes from freezing – as they did five times last winter!

We are very excited about our proposed new look and improving the facility for our patients and volunteers. We are currently applying for grants to cover the cost of the renovation project. In kind donations of needed equipment and construction materials would also be appreciated. If everything goes according to plans, we anticipate starting the proposed renovation project by late spring or early summer.

Single Mom Receives Care

Some would say The CARE Clinic is a Godsend. Janet is one patient who would agree. She is a single mom who works as a waitress at a small restaurant. Paychecks are nothing to brag about and tips are practically nonexistent. Her teenager works part time while going to high school to help out with the bills. Janet was trying to see a physician in his office but had no way to pay for her visits. She was referred to The CARE Clinic and promptly called for help. She qualified and is currently being seen at The CARE Clinic where she receives the care and medications she needs. Each month she donates as much as she can to help give care to other patients. Janet's employer also appreciates the care we give her, which allows her to have healthier days at work. He is so grateful in fact, that he sent in food from the restaurant specifically for the Thursday afternoon staff and volunteers. That afternoon we were the grateful ones.



Asthma and Allergy Clinic

We are pleased to announce the addition of a monthly Asthma and Allergy Clinic. Dr. Joseph Follett is generously donating his time and talents to help CARE Clinic patients the second Wednesday of each month. Our first clinic was held on November 9. To be seen during the specialty clinic, patients must be screened by one of our volunteer providers during an evening clinic and referred to the Asthma and Allergy clinic. Held in conjunction with our regularly scheduled Wednesday evening clinic, Dr. Follett will see six to eight patients during each specialty clinic.



The clinic is being well received by our patients, who appreciate the opportunity to see a specialist during our evening hours. Thank you, Dr. Follett, for allowing us to offer this specialty care to our patients on site.

The CARE Clinic Serves as Clinical Site for Students

In the past three years The CARE Clinic has served as a clinical site for health care students needing a community health or medical office site for hands on experience. Registered nurses completing their Bachelors of Science degree in Nursing from East Carolina University, Fayetteville State University, Deaconess College, University of Central Florida, University of North Carolina at Greensboro, and University of North Carolina at Chapel Hill have been students at the clinic. Students must often complete a project that will benefit the clinic. One student conducted a class for patients with hypertension. All those materials are still available for use by the clinic. Another student reorganized the clinic's patient teaching materials and put up signs to let patients know they can ask for information and to let the volunteers know the information is available for them to use. Another student revised the clinic's material safety data sheets notebook by getting all the sheets for the materials identified.

Since January, two certified medical assistant students have been doing their externships with the clinic. One student is from Sanford Brown Institute and the other from High Tech Institute.

Students preparing to apply for admission to nursing school, a physician's assistant program or medical school also volunteer to get more clinical experience. The clinic provides a convenient opportunity as many of these volunteers and students work during the day. They also provide the clinic with extra hands to help take care of patients. Many become faithful volunteers once their school experience is over.

The CARE Clinic participated in a site visit by the Commission on Collegiate Nursing Education, the organization which accredited the new nursing program at Fayetteville State University. The instructor who was involved with this said that the surveyor was very impressed that the university was using The CARE Clinic as a clinical site and this helped the university attain their accreditation. By having students at the clinic, both the student and the clinic benefit.

Retired Health Professionals Invited to TAP-IN

The American Health Initiative has launched a new program, **TAP-IN**, to help meet critical needs of Free Clinics through the volunteer engagement of retired health professionals to care for the uninsured. **TAP-IN** is designed to boost Free Clinic volunteerism among six groups of retired healthcare professionals: physicians, dentists, nurses, pharmacists, psychologists, and social workers. It will focus initially on recruiting physicians over age 55 who are retired or nearing retirement, linking them with the nearly 100 Free Clinics operating in Virginia and North Carolina.

North Carolina and Virginia were chosen as sites to launch **TAP-IN** because they lead the nation in total number of Free Clinics. Both states have well organized State Free Clinic Associations that represent a majority of the Free Clinics in the area, have very low cost retiree medical malpractice insurance arrangements, and offer a strong pool of potential volunteers. Both the North Carolina and Virginia Associations of Free Clinics have agreed to partner with **TAP-IN** in developing and refining the program.

TAP-IN will be launched in the spring of 2006 by targeting physicians to volunteer in seven test clinics in North Carolina and Virginia. The CARE Clinic has been selected as one of the four North Carolina Free Clinics participating in the pilot program. The other North Carolina clinics are The Moore Free Care Clinic in Carthage, The Raleigh Rescue Mission, and The Open Door Clinic in Raleigh. The program will then be extended to the nearly 100 clinics in N.C. and VA before being rolled out nationally and extended to other professionals such as dentists, nurses, pharmacists, and social workers.

Since many retired professionals regret the loss of professional identity and collegiality that often accompanies retirement, **TAP-IN** will provide the opportunity for senior volunteers to stay as engaged, as little or much as desired, practicing in a friendly, hassle free environment where their services are deeply appreciated.

A Big Win for the FireAntz! A Big Win for The CARE Clinic!

Our second annual CARE Night with the FireAntz was a huge success! On November 4, 2005, supporters of The CARE Clinic and supporters of the FireAntz came out to the Crown Coliseum to cheer for our hockey team. The FireAntz had their second win of the season beating the Jacksonville Barracudas 5-3. The night was also a big win for the clinic; with 322 tickets sold by the clinic. A net profit of \$1,300.00 went to The CARE Clinic to help provide services for the uninsured adult residents of Cumberland County.
