A Blessed Mission

Patients without medical insurance get a lot of attention in the media, but you seldom hear about the plight of patients without dental insurance. Because of the cost, patients without insurance usually put off seeing a dentist until the only thing that can be done for them is to pull the tooth to relieve the pain. Sadly, the number of patients calling for dental extractions greatly exceeds the number of appointments we have available. Dental appointments are made every Friday morning and the phone lines stay busy.

Henry had been suffering from a painful tooth for some time when he learned about The CARE Clinic. Although getting an appointment is difficult for many of our patients, Henry had the additional challenge of being deaf and needing a hearing person to make the call for him. Fortunately, Henry got an appointment. Because of his special needs, we asked Henry to bring someone with him who could help him communicate with our volunteers in the dental clinic. Henry came in as scheduled but was unable to find a hearing friend to come in with him. Imagine Henry's surprise - and ours - when one of our volunteer nurses started talking with him using sign language! Henry immediately became more relaxed knowing he could communicate with the dentist, and the dentist would be able to understand his concerns.

It is amazing how often "coincidences" like this happen at The CARE Clinic. Our mission is indeed blessed, and our wonderful volunteers and donors are truly angels on earth.

GROUND BREAKING CEREMONY

We're excited to announce we kicked off construction of our new clinic with an official ground breaking ceremony on Friday, March 16th. Advantage Hospice and Home Care provided breakfast for CARE Clinic supporters who braved the rainy weather to attend the ceremony.

Joey Boles, past president of our Board of Directors, emceed the event. Ken Lancaster, chair of the Facilities Committee, shared information about the need for the new clinic with those attending the ground breaking.

The new, 6,000 square foot facility will be located directly behind our existing clinic, which will be razed and converted into a parking lot.

As we've previously reported, our Facilities Committee initially looked at updating the existing clinic, going so far as to draw up plans to put a new roof over the clinic in order to eliminate roof leaks. They also planned to refurbish the building's exterior to make it maintenance-free.

"The builder brought an engineer in to look at our building, and it couldn't handle the wind load with the type of roof we wanted to put on it," says Joey Boles. "In a few years we would have been right back where we are now. We wouldn't be spending the money wisely that people give us."

Giving the old clinic a facelift would have cost approximately \$500,000. The external appearance of the building would be improved, but many of the functional concerns would remain the same. It turned out a larger, completely new structure more suited to our needs could be built at a not to exceed price of \$825,000. So the committee redirected its energies to design a brand new clinic.

With 2,000 extra square feet, the new clinic will include a

medical records room, a room for sterilizing dental instruments, and a procedure room. Currently, chiropractic patients are treated in a curtained area of the board room. The procedure room will provide a private area for chiropractors to see patients on Tuesdays and Thursdays, and for our dermatologist and allergist to hold their specialty clinics on Wednesday nights. In addition, problems with freezing pipes, roof leaks, and poor temperature control will be a thing of the past.

"We've had several roof leaks," Joey adds. "Some of the water piping is run outside so we've had some freezing pipe issues. We had a horrendous rainstorm several months ago and the kitchen area flooded. It's just time for a new clinic."

Many generous donations are making this building project possible. For example, architect Tom Goetz has donated his services to design the new building. Richard Player, III of Player Construction is working with local vendors in order to get building supplies donated free or at a reduced cost. Other donors include Kate B. Reynolds Charitable Trust, the NC Office of Rural Health, the Cannon Foundation, Sam's Club Foundation, and numerous donors who contributed towards meeting a challenge grant from the Cumberland Community Foundation.

"If we change our image, we're going to be able to help more people. If they feel like they're coming into a clinic that has the appearance of being a normal doctor's office, they're going to feel more comfortable about coming," Joey says. "Most of these are working class people; they just need a break. If we can change one person's life for the better or save one person's life, everything that we've done with that clinic has been worthwhile."

Eligibility Screening in Spanish

The CARE Clinic is now able to offer patient eligibility screening to patients who speak only Spanish. During our evening clinics, most patients who don't speak English bring a friend or family member with them to help translate. We also usually have a bilingual volunteer available who can serve as a translator when needed. However, when a Spanish speaking patient calls during the day to try to make an appointment, none of the staff or volunteers who are available are fluent enough in Spanish to ask medical questions or for the other information that is needed to determine eligibility. This has changed, thanks to the volunteer services of a bilingual retired nurse, Esther Smith.

Mrs. Smith started volunteering with The CARE Clinic in January 2006 after retiring from the VA Medical Center. A certified translator, Mrs. Smith offered to assist wherever needed. She had helped translate our post dental extraction instruction sheet and some other forms before she was invited to represent The CARE Clinic at an agency fair at a Hispanic church. It quickly became obvious the fair attendees could use the services we provide at The CARE Clinic but they would have difficulty making an appointment if they did not have a translator available. Mrs. Smith volunteered to come in during the day to learn how to screen patients. Now when a Spanish speaking patient calls, staff members get the patient's name and phone number and call Esther. She calls the patient, screens for eligibility, and confirms the appointment.

Muchas gracias to Esther for helping us increase the availability of our services to our Spanish speaking neighbors who need our help.

Selección de Elegibilidad en Español

La Clínica CARE puede ahora seleccionar la elegibilidad de los pacientes que solamente hablan Español. La mayoría de los pacientes que no hablan Inglés, usualmente traen a un familiar o amigo para ayudar a interpretar. También usualmente tenemos voluntarios bilingües que interpretan cuando es necesario. Sin embargo, cuando un paciente hispano llama durante el día tratando de hacer una cita, ninguno de los voluntarios ni del personal regular, tienen suficiente fluidez bilingüe para hacer el cuestionario médico necesario o hacer las otras preguntas pertinentes para determinar elegibilidad. Esto ha cambiado, gracias a los servicios voluntarios de una enferma retirada, Esther Smith.

La Señora Smith, indico sus servicios voluntarios para La Clínica CARE en Enero del 2006 despues de haberse retirado del VA Medical Center. La Señora Smith es intérprete certificada y ofrece sus servicios voluntarios donde sean necesarios. Ha ayundado a traducir la circular con las instrucciones para después de las extracciones dentales y algunos otros formularios antes de que guese invitada a representar La Clínica CARE en la feria de agencias ofrecida en una iglesia hispana. Durante esta feria, se hizo evidente que los que atendieron podían usar los servicios que se ofrecen en La Clínica CARE, pero que tendrían dificultad en hacer citas si no disponíamos de intérprete de Español. La Señora Smith ofreció venire durante el día a aprender a hacer la selección de los pacientes. Ahora, cuando un paciente que solo habla Español llama, el personal toma el nombre y número telefónico del paciente y llama a Esther. Ella llama al paciente, hace la selección de elegibilidad y confirma las citas.

Muchas gracias a Esther per incrementar la disponibilidad de servicios para nuestros vecinos hispanos que necesitan ayuda.
