A Life Saved

Celia, a Certified Nurse Assistant, came to our clinic for the first time last summer. A hard worker, Celia works at several different home health and hospice agencies. As a part time employee she does not qualify for health insurance coverage through her employers and cannot afford it on her own. Celia came to our clinic to be treated for high blood pressure. Upon discharge she was told to have some blood work done before her next appointment, which was in 3 months. Two weeks before her scheduled appointment Celia had the blood work done and was surprised to get a call from the clinic to come in for an earlier appointment. In a life changing moment, Celia was told she had leukemia.

Over the next few months Celia made many trips to Chapel Hill for treatment, completed her course of chemotherapy, and is now taking medication daily. As of February, Celia received the welcome news she is in remission, and she made a special trip to The CARE Clinic to share the good news with us. Celia wants to thank everyone involved with The CARE Clinic, from the medical volunteers to the donors who made her care possible, for saving her life.

Although not every patient has such a dramatic story to tell, moment like this remind us of the tremendous impact we are making in the lives of those we serve. Thank you for helping us provide care to deserving patients who might not otherwise receive the care they need.

We open the doors for our patients at 4 p.m. and are usually finished by 8:30 p.m. Dinner is provided for the volunteers by local church groups.

Fayetteville Church and Westminster Presbyterian Church have been serving as a church community at The CARE Clinic for several years.

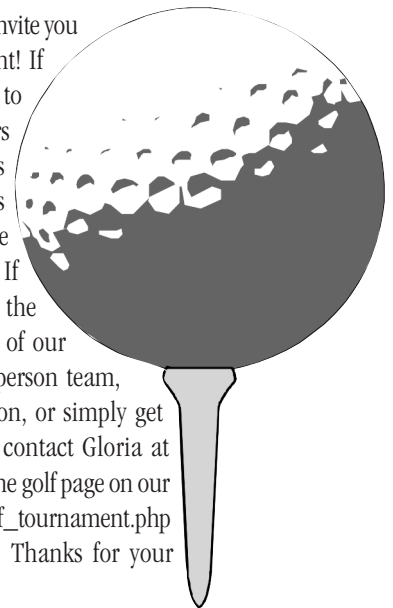
